



Partner Questions Arising from LIFT's Call for Proposals: Safe Migration and Empowerment for Migrant Women in Urban Centres

Second batch of questions (as of 9th October 2016)

1	How many proposals will be selected? Should the proposed budget under this CfP be in between a minimum and maximum amount?
	There is no fixed number for proposals to be selected. There is no minimum amount and the maximum amount is USD 4 million as stated in the Call for Proposals.
2	Does LIFT seek projects that are able to deliver sustainable results for all or selected intervention areas listed in the CfP?
	All of LIFT's CfPs are looking for sustainable project proposals.
3	Is there an obligation to submit a proposal in partnership with another organisation?
	There is no obligation to partner with other organisations. There is also no minimum or maximum number of proposals to be awarded.
4	What is the definition of 'urban centres'? Outside of Mandalay and Yangon, there are many other cities in Myanmar that contain high numbers of migrants. Additionally, many migrants go to peri-urban centres with large amounts of manufacturing jobs. Do you have any geographic locations in mind such as Dagon Seikkan, Aungmyathazan, Amarapura, Pyigyitagon and Hlaingtharyar? Please confirm the eligibility.
	The focus is on major urban centres such as Yangon and Mandalay. Industrial peri-urban areas around Yangon and Mandalay are however eligible.
5	Can we target source locations, and does the call include returning, or transit migrants? If source locations are permissible, would potential migrants also be a targeted group?
	The focus of this CfP is on female migrants from rural areas migrating for work to major Myanmar cities. The focus is not on source locations as LIFT is already supporting migration projects in this context.
6	Is there an anticipated minimum or maximum number of proposals to be awarded?
